#### **NEW VENTURE CREATIONS L2**

This qualification is designed for learners who intend to set up or have already set up own ventures

#### **NEW VENTURE CREATIONS L4**

This qualification is intended for persons who wish to start, operate, manage and grow a new small to medium business venture.

#### TRAINING AND DEVELOPMENT PRACTITIONER L5

A Learning and Development Practitioner plans, writes learning objectives, selects and adapts learning resources required for the delivery of learning interventions, and facilitates learning in an occupational context

#### SOCIAL AUXILIARY WORKER L5

A social auxiliary worker assists in the provisioning of social services and support to individuals, families, groups and communities with regards to a full range of social services and related social welfare matters.

#### EARLY CHILDHOOD DEVELOPMENT L4

An Early Childhood Development Practitioner plans and prepares early childhood activities, facilitates and mediates learning, observes and assesses the progress of children, and reflects on learning in an inclusive, play-based environment to support holistic development of children in different centre-based or non-centre based settings.

#### OCCUPATION HEALTH & SAFETY L5

Occupational Health and Safety Practitioners serve as a facilitator and advisor to employees and management regarding safety and health aspects in the workplace including the monitoring and inspecting of the workplace and the recording and investigation of incidents and accidents

#### HOME BASE PERSONAL CARE L2

Home Based Care Assistants provide basic physical and emotional support to patients and their families/household members within a home-based care environment. They work under the direct supervision of a professional supervisor

#### HOMEBASE CARE WORKER L3

Home Based Caregivers provide supervised care and support to patients and their immediate family's/household members in the home and appropriate community-based settings in order to promote, restore and maintain a person's maximum level of comfort, function and health including care towards a dignified death.

#### CHILD AND YOUTH CARE WORKER L5

A Child and Youth Care Worker contributes to the provision of holistic therapeutic care, and supports the development of children and youth in order to ensure the appropriate development of the individuals through the application of professional life space interventions

#### RELIGIOUS ASSOCIATE PROFESSIONAL L2

The purpose of this Qualification is to recognise those who have the required competence to serve as lay and ordained leaders in Christian communities or community organisations and society through enabling them to obtain a nationally registered and recognised Qualification.

#### CHRISTIAN RELIGIOUS PROFESSION L5

A Christian Religious Professional directs and conducts the ministry functions in a faith community in order to facilitate spiritual formation; nurture fellowship and mutual care within the faith community; helps members to develop a Christian lifestyle; provides strategic leadership that leads to obedience to vocation as well as well-being and sustainability of the faith community; and develops a missional practice that shares the good news of Jesus Christ and serves the holistic well-being of the entire

#### COMMUNITY HEALTH WORK L2

Community Health workers integrate a range of basic awareness and competencies to perform the roles of a health promoter, assistant, or health provider and assist the health networker within a community development context.
